

# Disaster and Emergency Preparedness and Response: Contest to Identify Promising Practices in Aging and Disability I&R/A Programs Submission Guidelines

### 1. Introduction

Information & Referral/Assistance (I&R/A) programs play a vital role in connecting individuals, caregivers, and families to needed services and resources. In regular times and in disasters and emergencies, I&R/A services answer the call. While I&R/A programs may play a variety of roles in disaster preparedness and response, the long-duration COVID-19 public health emergency created a unique set of circumstances that called for new levels of collaboration and innovation in serving communities and diverse inquirers. Whether this emergency situation or other types of disasters, I&R/A programs have valuable lessons and strategies to share for responding to all phases of disaster management.

The identification and sharing of promising practices from the I&R/A field can help strengthen current and future disaster readiness and response. In this context, the National Information and Referral Support Center, administered by ADvancing States and with funding provided in part by the Administration for Community Living, is launching this promising practices contest to identify and disseminate practices for disaster and emergency preparedness and response in aging and disability I&R/A programs. Contest eligibility and selection criteria and the application provide more information. We encourage organizations to think broadly about the roles of their I&R/A services in disasters and emergencies and welcome submissions from national, state, and community programs.

### 2. Eligibility

We invite promising practice submissions from aging and disabilities organizations that provide information and referral/assistance (I&R/A) services to one or more of the following populations: older adults, people with disabilities, and family and friend caregivers. We welcome a diverse array of promising practice submissions that address I&R/A services at any phase of disaster management (mitigation, preparedness, response and/or recovery). We encourage agencies both large and small, including those that serve rural communities, to share their promising practices.

### 3. Selection criteria

This promising practices contest will select several submissions for awards, and additional submissions beyond these may be identified for development and dissemination of promising practice profiles. Selection criteria include the following:

- a. The promising practice is relevant to I&R/A programs. It addresses I&R/A services for older adults, people with disabilities, and/or caregivers within the context of disaster preparedness and response.
- b. The promising practice reflects the importance of collaboration and partnerships in disaster and emergency situations.

- c. The promising practice offers ideas and lessons for future disaster preparedness and response.
- d. The practice shows a positive impact on I&R/A service provision in disasters or emergencies (for example, the practice supports the continuity of services in disaster situations).
- e. The practice recognizes the needs of a diverse range of inquirers in disasters and emergencies (i.e. the needs of older adults, people with disabilities, those with low access to technology).

### 4. Awards

Three promising practices will be selected for awards. The first, second, and third place awards are described below. Additionally, all awardee organizations will receive a certificate of recognition. And the I&R Support Center will work with each awardee organization to develop, publish and disseminate a promising practice profile. The profiles will be widely disseminated to aging and disability I&R/A agencies across the country, and will be posted to the ADvancing States website.

- 1st place award: Complimentary registration and lodging for one staff person for the 2022 National Home and Community Based Services (HCBS) Conference (August 14-18, 2022, Marriott Marquis Hotel, Washington, DC).\* The awardee will also receive recognition for its practice at the Information and Referral/Assistance Conference Intensive.
- 2<sup>nd</sup> place award: Complimentary registration for one staff person for the 2022 National Home and Community Based Services (HCBS) Conference. The awardee will also receive recognition for its practice at the Information and Referral/Assistance Conference Intensive.
- 3<sup>rd</sup> place award: Breakfast gift box and "swag bag" of ADvancing States goodies. A breakfast gift box to be enjoyed by I&R/A staff in the office or at home along with some ADvancing States swag.

The submission deadline is March 31, 2022.
