### This Month's Updates

#### **Medicaid Managed LTSS:**

- CMS approved **New Mexico**'s §1115 Medicaid demonstration proposal (entitled Centennial Care) in July 2013. The state plans to implement the demonstration in January 1, 2014.
- **Nebraska** Medicaid has started the process of developing a statewide Medicaid managed care program for the delivery of long-term services and supports, with a targeted implementation date in July 2015.

#### **Medicare-Medicaid Care Coordination Initiatives:**

- **South Carolina** has signed a Memorandum of Understanding with CMS to implement a dual eligible initiative called "Healthy Connections Prime".
- **Michigan** hopes to begin enrollment into their duals initiative beginning in July 2014. The state submitted a proposed Memorandum of Understanding to CMS in October 2013.

#### Community First Choice option under §1915(k):

• Arkansas projects implementation of the Community First Choice option in 2014.

#### Medicaid State Plan Amendments under §1915(i):

• Indiana has initiated the process of applying to CMS to secure federal funding for provision of Child Mental Health Wraparound (CMHW) services under §1915(i) of the Social Security Act.

#### **Medicaid Health Home:**

• **Kansas** will delay implementing Health Homes for people with Serious Mental Illness until July 1, 2014. (Previously, the state had intended to implement in January 1, 2014.) However, the state still anticipates implementing Health Homes for KanCare members who have other chronic conditions in July 2014 as planned.

Target<br>population includes individuals with two chronic conditions, one and at risk for<br>another or SMI, i.e., all the conditions listed in §2703 of the ACA, except BMI over<br>25.
