Mandatory Reporting

- Do you have mandatory reporting on your hotline?
- Varies from state to state
- Check with your supervisor/licensing board
- Anonymous vs identifying hotlines

Special Considerations

- First experience vs lifelong
- Historical trauma & cultural considerations
- Older adults experience every crime category
- 3x mortality rate
- Considered underreported
- Research is limited

Identifying Older Callers

- Listen for context clues
- Listen to terminology
- Explain why you are asking for age
- Older callers may tell you immediately
- Make a note if they say age is important

Tips

- Winston the dog
- Ask if it is safe to talk, have an exit plan
- Use the terminology they use
- Lower the pitch of your voice, but raise the volume
- Offer options and resources
- Assure confidentiality of the hotline caller
- Explain why you are asking questions
- Self-care

I need to know where to report abuse. Hospital staff hurt my mom and when I tried speaking to a supervisor they gave me the run-around. I asked to speak to security and was told to sit down. A few days later I called the police to report what happened and they didn't believe me. They took the hospital's side. No one is listening to me.

He gave me an account number and his badge number. I sent him money but he keeps calling and now he's threatening me. I can't go to jail. I thought I paid my taxes right last year, but now I don't know. Am I going to get arrested?
