Background

- Medicaid is administered by the Division of Health Services, Department of Social Services;
- HUSKY Health (Medicaid and CHIP) is a critical source of economic security and well-being to over 780,000 individuals (21% of the population of Connecticut);
- SFY 18 \$2.90B (net); \$6.85B (gross);
- Medicaid administers and is the primary operator of Long-Term Supports and Services.

Background

26 nursing homes closed since 2006;

2900 beds removed from the system;

 Department of Social Services estimates a surplus of 3000 nursing home beds through 2025;

Background

- Rebalancing Strategic plan led by steering committee;
- Plan based on jointly developed supply and demand projections;
- Plan developed in coordination with HUD, LeadingAge and CAHCF;
- One of five key focus areas in the plan is nursing home diversification;
- Plan is currently being revised with a focus on converting nursing homes to affordable housing

- Section 232 used to finance the purchase, refinance, construction or substantial rehab of residential care facilities (nursing homes, assisted living and board & care facilities)
