



## Links to Publicly Available American Rescue Plan Act HCBS FMAP Increase Spending Plans 7/28/2021

The American Rescue Plan Act of 2021 included an increase to the Federal share of costs related to Medicaid home and community-based services (HCBS). States are required to submit narrative information to the Centers for Medicare and Medicaid Services that describes the plans for expending the increased funding from this provision. Below is a compendium of those plans that have been publicly posted on the state agency website.
