
Mission

History: ACL's founding in 2012



- Principal agency in HHS leading aging and disability programs
- Reduce fragmentation and promote consistency in federal programs and policy addressing community living
- Enhance access to quality health care and long-term services and supports for older adults and people with disabilities
- Complement community infrastructure as supported by Medicaid and other federal programs



Priorities: COVID-19 Response in 2023

COVID-19 and Influenza Vaccine Uptake Initiative

- Awarded \$125 million to build and leverage partnerships with local CBOs to reach older adults and people with disabilities (awarded in December; subawards ongoing)
- Focus on hardest to reach people in most underserved communities

Test and Masks

- ASPR partnering with ACL to allow our aging and disability networks to distribute test kits; 172 aging and disability organizations have delivered almost 200k test kits to date
- In partnership with ASPR and the WH, ACL's aging and disability networks received information re partnering with pharmacies to re-distribute masks

PHE Unwinding

- Released a notice letter to Older Americans Act grantees on February 9 re PHE changes
- Collaboration with other OpDivs in outreach and education re insurance coverage, treatment and service changes applicable to older adults and people with disabilities





Disproportionate Impact of Disasters

- Disabled people and older adults often:
 - Cannot evacuate, use shelters or get information because of accessibility issues
 - Lose access to critical services and durable medical equipment
 - Are placed in institutions and can't return home
 - Ultimately suffer worse outcomes
- ACL's networks are uniquely positioned to partner with emergency and public health agencies to prepare for and address gaps
- Inclusive planning/preparedness is a priority for Administration, Congress, and aging and disability stakeholders



Priorities: Strengthening & Supporting Caregiving Infrastructure

Direct Care Workforce

- National crisis: Long-standing shortages worsened by COVID
- People needing services are increasing
 - 1.3 million workers needed by 2030
- Service providers are:
 - Declining referrals – 77%
 - Cutting services – 58%
- Without DCW services:
 - Many forced to live in institutions
 - Health & safety in the community is at risk

Family Caregivers

- 53m+ caregivers in the U.S. provide \$470B in unpaid care each year
- COVID increased demands and reduced support
- Lack of support hurts caregivers'
 - Physical and mental health
 - Economic security (\$522B in lost income each year)

Priorities: Strengthening & Supporting Caregiving Infrastructure

The Direct Care Workforce Crisis:

- Annual Turnover Rates: 42.8% – 64.8%
- Vacancy Rates: 8.5% -11.2%
- Need 1.3 million more workers by 2029
- Demand for service is growing faster than the labor pool

PROJECTED POPULATION GROWTH BY AGE GROUP, 2016 TO 2060







Expanding Access to HCBS and Other Critical Services

- HCBS Settings Rule
 - ACL staff part of the CMS implementation team
 - Review and approve all statewide transition plans by March and all Corrective Action Plans by fall 2023; Ongoing site visits (8 in 2022 and another 6 to 8 in 2023)
- Medicaid Access Rule
 - Collaborated with CMS on development of HCBS provisions
 - Particular focus on the direct care workforce, critical incident systems, and HCBS quality measures
 - Coordinating on roll-out (est. mid-April 2023)

Expanding Access (cont'd)

- Inflation Reduction Act (IRA)
 - Leveraging ACL's networks for outreach, education, and plan comparison assistance for Medicare beneficiaries (ongoing)
- Behavioral health
 - ACL launched a national TA Center for people dually diagnosed with I/DD and behavioral health needs in Sept. 2022
 - Establishing advisory committee (now); curating resources & launching resource hub (summer 2023); providing state TA (beginning fall 2023)
 - Partnering with SAMHSA, ACF, HRSA and CMS
 - ACL & TA Center working with SAMSHA to embed dual diagnosis into their 988 and crisis work (ongoing)

 - Partnership between HUD and HHS (ACL, ASPE, CMS, SAMHSA, CDC) to coordinate TA and leverage resources
 - Developed cross-agency FY 23 priorities and activities plan

 - National CCH learning community co-funded with CDC fall 2022
 - Center of Excellence to align social and health services (NOFO 2023)


- Identifies and proposes solutions to the problems surrounding elder abuse, neglect, and financial exploitation across the federal government.

Protection & Advocacy Systems (P&A's)

- Investigate suspected abuse or neglect and seek justice for victims and their families.
- Have access to records and facilities necessary to investigate abuse or neglect or to monitor the treatment and safety of residents.
- Pursue litigation and all other appropriate remedies under federal, state, and local law.
- Provide information and referrals regarding entitlements to services and other legal rights.
- Educate policymakers on needed reforms to disability-related laws and services.

Priorities: Equity

- Reaching underserved and marginalized communities is at the core of what ACL does and is embedded in statutes authorizing ACL programs.
- ACL is implementing Executive Orders on Equity, which identify individuals with disability and older adults as underserved populations
- Taking an intersectional approach, inclusion of population across HHS and federal government




The Older Americans Act (OAA)

*...assures that preference will be given to providing services to older individuals with **greatest economic need** and older individuals with **greatest social need** with **particular attention to low-income older individuals, including low-income minority older individuals, older individuals with limited English proficiency, and older individuals residing in rural areas.***

OAA is administered by the Administration on Aging (AoA) and helps **over 10 Million older adults (1 in 7) remain at home** through low-cost, community-based services.


The Population OAA Programs Serve

- Older adults with incomes below 150% of the federal poverty level.
- Older adults with additional risk-factors.
 - Examples: Lives Alone; Diabetes; Heart Condition; Minority; Rural
- Older adults at higher risk for ER visits & hospitalization.
 - Over 90% of OAA clients have multiple chronic conditions, compared to 68% of general older adult population (age = 65+)
 - 66% of Case Management Clients take 5 or more medications daily
- Older adults at higher risk for nursing home admission.
 - 42% of Home-Delivered Nutrition Clients require assistance with 3+ Activities of Daily Living (ADL).
 - 75% of Home-Delivered Nutrition Clients require assistance with 3+ Activities of Daily Living (ADL).



Adult Protective Services (APS) Notice of Proposed Rule Making (NPRM)

- First rulemaking regarding APS coincides with first awards of federal base funding for state APS systems
 - Establishes a minimum floor for states
 - Key stakeholder engagement 2016 through 2021
 - Will promote similar protections and service delivery across the country for older adults and people with disabilities
 - NPRM to be released August/September 2023

The Developmental Disabilities Act

Seeks to “assure that individuals with developmental disabilities and their families **participate** in the design of and **have access** to needed community services, individualized supports, other forms of assistance that promote **self-determination, independence, productivity, and integration and inclusion in all facets of community life ...**”

State Developmental Disability (DD) Councils

Councils are charged with:

- Identifying the greatest challenges facing people with DD in their state or territory
- Bringing together businesses, service providers, agencies, policy-makers, and community groups to find solutions
- Developing and testing innovative new programs and service models
- Bringing the voices of individuals with developmental disabilities and their families to policy-makers

Councils are:

- Federally funded
- Self-governing
- Appointed by a state's governor

60% of council members must be people with DD or family members.

University Centers for Excellence in Developmental Disabilities (UCEDD)

There are 67 UCEDDs across every state and territory. Centers, represent an expansive national resource for addressing issues, finding solutions, and advancing research related to the needs of individuals with developmental disabilities and their families.

- Core Services:
 - Interdisciplinary pre-service preparation and continuing education
 - Research and public policy analysis
 - Information dissemination
 - Community services, including direct services, training, technical assistance, and model demonstration projects

Protection and Advocacy Systems (P&A's)

- P&A's do the following:
 - Inform people of their rights
 - Investigate suspected abuse and neglect
 - Provide free legal representation to clients
 - Amplify the voices of the disability community
 - Engage in systems change work
 - Educate policymakers on the concerns of people with disabilities
- There are 57 P&A's across the nation.
- All P&A's operate independent of service providers.
- P&A's have legal authority to access records, facilities, and individuals when conducting investigations.

Projects of National Significance (PNS)


These projects focus on the most pressing issues affecting people with DD their families.

They also help ACL to fill gaps identified by the community and quickly address new issues with a national scope.

Independent Living (IL)

- IL is a cross-disability movement rooted in the philosophy of “Nothing about us without us.”
- In 1972, the movement gave birth to the Centers for Independent Living (CIL) in Berkley, CA.
- Ed Roberts (pictured to the right) and other disability rights activists were the founders of the CIL program.
- Today, there are over 350 CILs!

Paralysis, Limb Loss, and Traumatic Brain Injury (TBI) Programs

- **Limb Loss Resource Center** (operated by the Amputee Coalition) works to ensure the availability of, and access to, the most comprehensive, high-quality, evidence-based information, resources, and supports for people with limb loss and limb difference, their families, and their support networks.
- **The National Paralysis Resource Center** (operated by the Christopher & Dana Reeve Foundation) works to improve the quality of life for people living with paralysis through grants, information, and advocacy.
- **The TBI State Partnership Grant Program** helps states increase access to services and supports for individuals with TBI across the lifespan.
- ACL's **TBI Technical Assistance and Resource Center** helps grantees promote access to integrated, coordinated services and supports for people who have sustained a TBI, their families, and their caregivers. The Center also provides a variety of resources to non-grantee states, people affected by brain injury, policymakers, and providers.
- **Protection & Advocacy for Traumatic Brain Injury**

President's Committee for People with Intellectual Disabilities (PCPID)

- Provides advice and assistance to the President of the United States and the Secretary of Health and Human Services
- Promotes policies and initiatives that support independence and inclusion of people with intellectual disabilities in their communities
- Improves quality of life for people with intellectual disabilities by upholding their full citizenship rights, independence, self-determination, and lifelong participation in their communities

Assistive Technology (AT) Act Program

- There are 56 state and territorial programs that serve approximately 500,000 people annually.
- AT Programs offer the following:
 - Help older adults and people with disabilities identify AT solutions
 - Device demonstration and short-term loan programs (“try before you buy”)
 - Reuse programs that provide gently used devices at substantial savings
 - Financing options



Partnership: Housing

- Ongoing partnerships with HUD, ASPE, CMS, Health Plans, Housing Providers, States and Communities
- New **ACL Housing Resources TA Center** promotes cross-sector partnerships across federal, state, local, tribal, private, and nonprofit organizations working in the housing, home and community-based services, homelessness services, and health sectors.

Partnership: Transportation

- ACL supports the development of convenient, affordable, and accessible transportation options
- Longstanding partnership with the Federal Transit Administration and Coordinating Council on Access & Mobility (CCAM) members
- **Transit 4 All:** an inclusive and coordinated transportation-planning project that has funded a series of pilot projects across the nation

Partnership: The VA's Veteran Directed Care (VDC) Program

The Veterans Health Administration's VDC program provides veterans with greater choice and control over their services and supports

- **Veterans can:**

- Choose the services and supports they use
- Hire their own workers, including family and friends
- Live in their own home and community
- Achieve goals meaningful to them


- **VA Medical Center (VAMC) Responsibilities:**

- Determine eligibility for VDC
- Provide a monthly budget
- Refer veterans to a VDC provider
- Approve veterans' spending plan

- **VDC Provider Responsibilities:**

- Listen to veteran's goals and needs
- Help veterans plan for your services
- Connect veterans to community resources
- Serve as a visible and trusted organization in the community

The LTSS Puzzle: The Need for a Coordinated No-Wrong Door System



No Wrong Door (NWD) System Vision

-  A single system available to **all populations** who need or may at some point need Long-Term Supports and Services (LTSS) and **all payers** who help to finance LTSS.
-  The NWD System seamlessly connects individuals to the full range of LTSS community-based options available.
-  Through a network of community-based organization (CBOs), NWD expands access to services and supports, **helping individuals and their caregivers** navigate resources they need with a **person-centered approach**.
-  Coordinated at the state level by a strong governance structure to coordinate policy, technology/data infrastructure and resource allocation across the network of CBOs.

State Health Insurance Assistance Program (SHIP)

- **Mission:** to empower, educate, and assist Medicare-eligible individuals, their families, and caregivers through objective outreach, counseling, and training, to make informed health insurance decisions that optimize access to care and benefits.
- **54 Grantees:** One in every state, DC, PR, & USVI (2/3 in State Units on Aging; 1/3 in Dept of Insurance)
- Provide one-on-one assistance to Medicare beneficiaries who prefer or need information, counseling, and enrollment assistance beyond what they are able to receive on their own through other sources
- Built on over 3,300 local partnerships with AAAs, CILs, senior centers, and other community organizations to host 14,000 team members (approx. 50% are volunteers)

Senior Medicare Patrol (SMP)



Mission

To empower and assist Medicare beneficiaries, their families, and caregivers to prevent, detect, and report health care fraud, errors, and abuse through outreach, counseling, and education

- **54 State Projects:** One in every state, DC, PR, GU, and USVI with 6,900 team members nationally
- **SMP's goals:**
 - To prevent Medicare fraud before it happens via public outreach and one-on-one assistance and
 - To report suspected issues as quickly as possible to the proper investigators
- SMP is known as a trusted OIG & CMS partner and provides a direct link from Medicare beneficiaries to fraud investigators
 - Example: OIG credits SMP with first notifying them of genetic testing schemes in 2019.

Medicare Improvements for Patients and Providers (MIPPA) State Grants

- MIPPA provides additional funding to existing infrastructure created by SHIPs, AAAs, and ADRCs
- Funding is for
 - Conducting outreach to low-income Medicare beneficiaries
 - Assisting low-income Medicare beneficiaries with enrollment into the Part D Low-Income Subsidy (LIS/Extra Help) and the Medicare Savings Programs
- Projects exist in every state, DC and PR, but not all states receive all three funding streams (state's decision)
- Most recently reauthorized with 2021 Budget = Level funding through FY 2023.
- Annual Amounts:
 - \$15M for SHIPs
 - \$15M for AAAs
 - \$5M for ADRCs

National Center for Benefits Outreach & Enrollment (NCBOE)

- The NCBOE MIPPA grant was awarded to the National Council on Aging (NCOA)
- \$15M in funding in FY 2022
- NCOA will:
 - Serve as the resource center for MIPPA grantees
 - Establish **Benefits Enrollment Centers (BECs)** to assist Medicare beneficiaries with limited income and assets apply for Extra Help, Medicare Savings Program, SNAP, LIHEAP, etc.
 - Foster the use of cost-effective benefits outreach and enrollment strategies
 - Promote the use of **Benefits Check-up**, a web-based decision support, screening, and enrollment tool that screens for a wide range of benefits for those with limited income and assets
 - Maintain an online information clearinghouse of promising practices related to benefits outreach and enrollment
